Message From the President

Poor Debbie Gilson had to deal with this. In the process of tracking down the cause it was discovered that the permit issued to the Tustin Tennis Club 5 years ago expired. I'm proud to say that we now have a 5 year permit that expires on Monday September 9th, 2019. The permit is posted in our Bulletin Board at the courts. But in order to get this permit I had to sign an Agreement with the Tustin Park District. Most of the agreement is just boiler plate stuff, but of significance to us is that our club will have the responsibility to pay for new nets every two years at the Magnolia Tree courts. About a \$600 expense. So treat them gently. Another not so minor requirement is that the Tustin Park District now requires they be named coinsured on our liability insurance for \$1,000,000. Well that's all settled now.

The cost is substantially less than prior years for a great menu because our club is getting the hall for free. Unfortunately the Cerritos Bahia Yacht Club clubhouse is not big enough to hold all our TTC members and their partners. So we may have to turn you away if you are late turning your check into me. The deadline is November 21.
