Include anything else that you think is pertinent. The information could be a life-saver. Peggy was there to help Dave, but no one had the information for Larry. If you don't have the information in your pockets or in your tennis bag already, I suggest we all develop and carry a list with us.

Cliff ran the Friday night tennis tournament on 3/3. Ishwar came in first. The results are provided later in this newsletter. Nobody responded to have one on 3/10 so it was cancelled. However, 4 players who played on Friday morning decided to meet again in the evening.
